

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to www.reggaeroofing.com, and Reggae Roofing Inc. and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Reggae Roofing Inc. include www.reggaeroofing.com. The Reggae Roofing Inc. website is a information site. Collection of your Personal Information

In order to better provide you with products and services offered, Reggae Roofing Inc. may collect personally identifiable information, such as your:
